The provision of a base plate is required for exhibits exceeding 2000 kg. The Organizers must be informed of any such exhibits. They must arrive in good time for port clearance and reach the exhibition site on the first day of build-up.

**Note:**

- ✓ **To secure Custom's temporary import approval, the commercial invoice & packing list has to be provided 20 working days prior to the shipment's arrival in Muscat**
- ✓ **All goods should arrive at Muscat International Airport minimum of 1 week before the first day of moving in the Convention Center.**
- ✓ **Clearing in Sohar Port will require a minimum of 15 working days to be cleared from Customs.**
