A copy of the visa will be sent to you by Omanexpo and must be shown to the airline at the check-in desk on departure. Failure to do this will prevent boarding.
- Those travelling from UAE to Oman via road, original visa should be obtained to grant entry through the border.
- **Pakistani & Indian Nationals should request ok to board** note through their airline by providing the copy of the visa and the visa deposit slip. All exhibitors are fully responsible of their itineraries. Ok to board will not be submitted without a confirmed flight with PNR. Omanexpo will not be responsible for any delay if the exhibitor did not provide the flight details on time.

**Visa Information**

A visa is required by all persons entering the Sultanate of Oman with the exception of GCC nationals (UAE, Saudi Arabia, Oman, Kuwait, Bahrain, and Qatar). Non-GCC nationals working in GCC states can obtain visas at the arrival point provided they hold a designation which is included in the list of permitted titles.

Various nationalities (mentioned in the list below) can obtain visit visas on arrival at all land, sea and air terminals whether individually or as part of a group, regardless of their sex or age. Visas can also be obtained by these nationals if once they apply to Oman diplomatic missions and commercial representation offices.

The validity period of the applicant's passport should not be less than 6 months.
